- Rates are quoted excluding 15% VAT and all Airport Taxes.
- Rates are quoted for 4 adults per plane per charter and apply to routings in either direction.
- Final Rates are subject to quote in order to ascertain the impact of fuel price increases, airport charges, US dollar exchange rates etc. on the quoted rate.
- Rates are subject to the availability of the aircraft on the day of confirmation of the flight.
- All rates quoted are subject to change, without prior notice.

RATES INCLUDE:

- Aircraft, crew, maintenance, fuel and insurance.
- En route, approach, landing, parking fees, handling, VSAT and TASP.
- Live satellite tracking.
- Overflight clearances and landing permits.
- Light in-flight catering and non-alcoholic beverages.
- All passenger departure taxes and SARS levies.

RATES EXCLUDE:

- Aircrew accommodation (minimum 4 star, one room per crew member), meals and road transport in the event of a night-stop.

- Day rooms (one room per crew member) required for aircrew spending four (4) hours or more at a particular destination.
- Visa fees.
- Additional charges incurred when operating outside an airport's normal hours of operation.
- All costs associated to cargo handling, loading, and including "royalties"
- Additional kilometres flown for route changes by client once flight has been dispatched
- Road transfers or any alternative arrangements in the event that we cannot land at unserviceable runways (water-logged, rough surfaced) which pose a danger to passengers, crew and aircraft.
- Satellite phone calls

TERMS & CONDITIONS

ALL QUOTED RATES are NETT of local and foreign exchange. Bank fees and will be for client's account

AIRCRAFT AVAILABILITY: These rates are aircraft specific and are subject to aircraft availability and serviceability on date of confirmation. An aircraft will be reserved once written confirmation of the acceptance of the quotation and these Terms and Conditions have been received. Seasons in Africa Charter Co. does however reserve the right to substitute the aircraft with a similar aircraft at the same price without notice to the client in the event of a last-minute change.

You are required to meet the take-off time as agreed in the quotation. If you are late due to your own actions or by circumstances surrounding your actions, and the aircraft is required for further charters on the same day, you may possibly forfeit your flight and you will be required make other arrangements at your own cost to your destination.

FUEL AVAILABILITY: These rates subject to the correct aviation fuel being available at the destination, or en-route.

INDUSTRY & AVIATION RELATED FUEL PRICE INCREASES / VALIDITY OF QUOTATION: Should a quotation be provided long in advance and industry related price increases are experienced; the quotation may have to be reviewed.

DANGEROUS GOODS: Dangerous Goods as per the IATA Dangerous Goods Regulations must be declared. Goods delivered and incorrectly packed and without the correct documentation will not be allowed on our aircraft.

OPERATING HOURS: Flights are restricted to daylight operating hours, unless otherwise agreed to, or unless the destination airport is fully equipped with night landing facilities. We are restricted to operating hours at certain airstrips as set out by SA Parks.

PAYMENT: Full payment will be required prior to departure of the flight, unless the client has an arrangement with Seasons in Africa Charter Co. regarding payment. Seasons in Africa Charter Co. reserves the right to demand a non-refundable deposit to secure a flight booking.

METHOD OF PAYMENT: Any of the following methods are accepted, namely; bank guaranteed cheque, direct bank transfer, direct bank deposit or cash. All Major Credit cards are accepted (Visa / Master / Diners and Amex) but a 5% surcharge will be applicable.

WEATHER DIVERSIONS AND DELAYS: Weather is monitored on a 7 day forecast. This allows us to pre-determine potential 'no fly' days. The decision to fly in adverse weather conditions is at the sole discretion of the Captain in command of the aircraft. His decision is final.

Seasons in Africa Charter Co. will not be held responsible for any additional costs incurred if we are unable to land at the airstrip booked due to diversions, technical issues, weather, unserviceable airstrips and waterlogged airstrips.

The client also hereby accepts that Seasons in Africa Charter Co. will not be held liable for unforeseen delays caused by circumstances beyond our control including technical issues, lodge transfer delays, adverse weather, air traffic delays, or delays caused by employees of various airports or delays caused by other passengers on the shared charters. The cost of alternative arrangements are for the client's account which include road transfers, onward scheduled flights and or additional accommodation. Clients are urged to have the relevant Travel Insurances in place to facilitate these unforeseen costs.

OVER FLIGHT AND LANDING PERMITS: Flights shall not be dispatched without all the relevant permits being obtained by authorities in neighbouring countries and or in privately owned airfields.

EMPTY LEGS: Seasons in Africa Charter Co. reserves the right to utilize the aircraft for its own needs on any flight sector that is not utilized by the client.

OUTSOURCED AIRCRAFT: Seasons in Africa Charter Co. reserves the right to utilize a subleased aircraft without notice to the client when deemed necessary. You acknowledge that this charter may not be performed by Seasons in Africa Charter Co. and this charter may be carried out by an undisclosed principle carrier on behalf of Seasons in Africa Charter Co.. The terms and conditions agreed herewith will then be in favour of such principle carrier and you hereby waive any claims against Seasons in Africa Charter Co..

AIRSPACE CLEARANCES / ARRIVAL AND DEPARTURE SLOT TIMES ORT INTERNATIONAL: We cannot be held liable for delays at ORT, re-scheduled slot times and or denied permissions for arrivals or departures by the Central Airspace Management Unit.

LUGGAGE: You are permitted one (1) standard piece of soft sided luggage not exceeding 20kg. In addition you may carry on board a handbag, clutch bag, coat, umbrella, laptop and small items of camera equipment weighing not more than 5kg. Excess luggage (more than 20kg) or luggage that does not meet the criteria as set out in our quotation will be decided upon by the Captain in command of the aircraft. If the items are not loaded, onward arrangements and cost thereof will remain the client's responsibility.

SMOKING: Smoking on Seasons in Africa Charter Co. flights is strictly forbidden.

CANCELLATION: Seasons in Africa Charter Co. reserves the right to charge the following cancellation fees

50% cancellation fee applicable 15 - 29 days prior to departure of flight.

75% cancellation fee applicable 7 - 14 days prior to departure of flight.

100% cancellation fee applicable 6 days prior to departure of flight.
